Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.



## Auditor General's report

### Audit opinion – Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

### Basis for Qualification

#### Accounting Statement

In my opinion, the accounting statement has not been prepared in accordance with proper practice and do not properly presents the Council's receipts and payments and financial position:

- The council has incorrectly adjusted the accounts for cheques that were issued before but not presented to the bank at 31 March 2022. The accounts are mis-stated as follows:
  - Line 6 is understated by £996
  - Lines 7, 9 and 11 are overstated by £996
  - Line 10 is overstated by £996

### Other matters arising and recommendations
